

**DEBTOR AND CREDITOR GUIDE REGARDING FIXED HEARING DATES IN JUDGE  
TUCKER CASES**

Once the judge has issued an order Under L.B.R. 9013-4 setting fixed (also known as omnibus) hearing dates, the clerk will pre-set hearing dates, making them available as a pull-down menu in CM/ECF. Since the hearing dates only appear with the use of certain docketing event codes, the following set of instructions will walk you through the correct process. The key to successfully setting an item for a fixed hearing date is that the filer must file the motion, proposed order and exhibits as one document. A notice and opportunity **must** be filed as a separate document, using a different event code.

In CM/ECF, do the following:

1. **File the motion, proposed order, and exhibits as a single document.**
2. **Select “Notices” under the “Bankruptcy Events” menu. Enter the case number and select “Next”.**
3. **Under the list of available events, select “Notice of Omnibus Hearing” and select “Next”.**


