

**NOTICE TO CHAPTER 13 BANKRUPTCY PRACTITIONERS
FOR CASES ASSIGNED TO JUDGE THOMAS J. TUCKER
EFFECTIVE APRIL 7, 2005**

As the Court announced in December, beginning on Thursday, April 7, 2005, both Judge McIvor and Judge Tucker will hear Chapter 13 matters on Thursdays.
