**NOTICE REGARDING AMENDMENTS TO FEDERAL
RULES OF BANKRUPTCY PROCEDURE, NEW OFFICIAL FORMS
AND INTERIM AMENDMENTS TO LOCAL BANKRUPTCY RULES**

On December 1, 2011, amendments to the Federal Rules of Bankruptcy Procedure become effective. Existing Rules 2003, 2019, 3001, 4004 and 6003 have been amended. In addition, new Rules 1004.2 and 3002.1 have been created. New Official Forms B1 (Voluntary Petition), B10 (Proof of Claim), B10 (Attachment A), B10 (Supplement 1), and B10 (Supplement 2) also become effective on that date. The amendments to the Federal Rules of Bankruptcy Procedure, a blacklined version of those amendments, and the new Official Forms can all be found at www.uscourts.gov/RulesAndPolicies/FederalRulemaking/Overview.aspx.

To implement the amendments to the Federal Rules of Bankruptcy Procedure and the new Official Forms, the Bankruptcy Court for the Eastern District of Michigan has created the following new event codes for filing under CM/ECF:

Notice of Mortgage Payment Change. (This pleading is filed on the case docket and will automatically spread to the claims register.) (This new event replaces existing event Statement of Proposed Change in Periodic Payment with Certificate of Service.)	B10 (Supplement 1)
Notice of Postpetition Mortgage Fees, Expenses, and Charges. (This notice is filed on the case docket and will automatically spread to the claims register.)	B10 (Supplement 2)
Response Agreeing with Notice of Final Cure Payment.	No form
Response Disagreeing with Notice of Final Cure Payment.	No form

NEW EVENT	NEW OFFICIAL FORM
Motion to Determine Mortgage Fees and Expenses.	No form
Motion to Determine Final Cure Payment.	No form
Notice of Completion of Plan Payment and Notice of Final Cure Mortgage with certificate of service.	No form

Two of the existing Local Bankruptcy Rules for the Eastern District of Michigan, Local Bankruptcy Rule 2015-5(a) and Local Bankruptcy Rule 3001-2, contain provisions that conflict with new F.R.Bankr.P. 3002.1. As a result, the Bankruptcy Court for the Eastern District of Michigan has entered Administrative Order No. 11-08 to amend Local Bankruptcy Rule 2015-5(a) and Local Bankruptcy Rule 3001-2 on an interim basis to conform them to new F.R.Bankr.P. 3002.1 until such time as permanent amendments to these Local Bankruptcy Rules may be made. The interim amendments to Local Bankruptcy Rule 2015-5(a) and Local Bankruptcy Rule 3001-2 also become effective December 1, 2011.
