Directions:

From the East

Travel M-25 to Center Avenue. Follow Center Avenue to Washington Avenue. Turn right on Washington Avenue. Follow Washington Avenue to First Street. Turn left onto First Street. The building is located one block down on First Street, at the corner of First and Water Streets.

From the West

Follow M-10/M25 to Washington Avenue. Turn left onto Washington Avenue Travel Washington to First Street. Turn left onto First Street. The building is located one block down on First Street, at the corner of First and Water Streets.

From the North and South

Travel I 75 to Exit 162 (Downtown Bay City exit). Follow Thomas Street to Washington Avenue. Turn left on Washington Avenue. Take Washington Avenue to First Street. Turn left onto First Street. The building is located one block down on First Street at the corner of First and Water Streets.

From the South

Travel I-75 N. Keep right at the fork to continue on I-475 N, follow signs for Interstate 475/Downtown/Flint. Take exit 7 toward Downtown/Court St. Turn left onto E.Court St. Turn right onto S. Saginaw St. Turn right where it forks and destination on the right.

From the North

Travel I-75 S towards Flint. Take exit 125 for I-475 toward Downtown/Flint. Take exit 8A toward Longway Blvd. Merge onto Chavez Dr. Turn right onto Robert T Longway Blvd. Continue onto E 5th Ave. Turn left onto Saginaw St. Destination will be on the left.

From the East

Travel I-69 W towards Flint. Take exit 136 for Saginaw St. toward Downtown. Turn right onto S. Saginaw St. Turn right where it forks and destination will be on the right.

From the West

Travel I-69 E. Take exit 136 toward Saginaw St/Downtown. Turn left onto S. Grand Traverse St. Turn right onto W. Kearsley St. Turn left onto S. Saginaw St. Turn right where it forks and destination will be on the right.

Parking

A public parking structure is located on the South side of the Bankruptcy Court building. Entrance to the parking structure is on Beach Street. There is also limited meter parking on the streets adjacent to the court.

Directions:

From the East

I-69W to the Downtown/Saginaw Street exit. Follow service drive to the second traffic light which is Church Street. Turn right on Church Street. The Federal Courthouse is on the left-hand side of the road.

From the West

I-69E to the Downtown/Saginaw Street exit. Follow the service drive to the second traffic light which is Church Street. Turn left on Church Street. The Federal Courthouse is on the left-hand side of the road.

From the North

I-75 South to I-69 East. Exit at the Downtown/Saginaw Street exit. Follow the service drive to the second light, which is Church Street. Turn left on Church Street. Continue on Church Street to Second Street. Turn right. Travel Third Street to Church Street. Turn right on Church Street. The Federal Courthouse is on the left-hand side of the road.

I-75 South to I-475. Exit at the Downtown/Court Street exit. Follow the service drive to Third Street. Turn right. Travel Third Street to Church Street. Turn right on Church Street. The Federal Courthouse is on the left-hand side of the road.

From the South

US-23 North to I-75 North to I-69 East. Exit at the Downtown/Saginaw Street exit. Follow service drive to second light, which is Church Street. Turn left on Church Street. The Federal Courthouse is on the left-hand side of the road.

I-75 North to I-475. Exit at the Downtown/Court Street exit. Follow service drive to Court Street. Turn left onto Court Street. Follow Court Street to Church Street. Turn right on Church Street. The Federal Courthouse is on the left-hand side of the road.

Parking:

A public parking structure is located on the South side of the Bankruptcy Court building. Entrance to the parking structure is on Beach Street. There is also limited meter parking on the streets adjacent to the court.

Directions:

From the East

I-94 west to I-75 south to I-375 downtown. Exit I-375 at Jefferson East and turn right on Congress Street. Continue on Congress Street until you reach Washington Boulevard (three blocks past Woodward Avenue) and then turn right. The court is one block up on the right side of the street.

From the West

I-94 east to Lodge Freeway south. Exit from the left lane at Larned Street and turn left at the traffic light, which is Washington Boulevard. The court is two blocks up on the right side.

From the North

I-75 south to I-375 downtown. Exit I-375 at Jefferson East and turn right on Congress Street. Continue on Congress Street until you reach Washington Boulevard (three blocks past Woodward Avenue) and then turn right. The court is one block up on the right side.

From the South

I-75 north to Lodge Freeway south. Exit from the left lane at Larned Street and turn left at the traffic light which is Washington Boulevard. The court is two blocks up on the right side.

From the North

US 23 South to Exit 45 (M-14 W) toward Downtown/AnnArbor. Take the US-23 Bus exit, Exit 3 toward Downtown/Ann Arbor. Stay straight to go onto N. Main St/US-23 Bus S. Continue to follow N. Main St. Turn left onto E. Liberty St. 200 E. Liberty Street is on the right-hand side of the street.

From the South

US 23 North to Exit 37B (I-94 Bus W./US-23 Bus N) toward Ann Arbor. Turn left onto S. 5th Ave. Take the 2nd right onto E. Liberty. 200 E. Liberty Street is on the left-hand side of the street.

From the East

I-94 W to Exit 175 (Saline Road) toward Ann Arbor. Turn right onto Ann Arbor Saline Road (becomes Main Street). Turn right onto E. Liberty Street. 200 E. Liberty Street is on the right-hand side of the street.

I-96 W to Exit 45 (M-14 W) toward Downtown/AnnArbor. Take the US-23 Bus exit, Exit 3 toward Downtown/Ann Arbor. Stay straight to go onto N. Main St/US-23 Bus S. Continue to follow N. Main St. Turn left onto E. Liberty St. 200 E. Liberty Street is on the right-hand side of the street.

From the West

I-94 E to Exit 172 (I-94/Ann Arbor). Keep left at the fork in the ramp, then stay straight to go onto Jackson Ave. Jackson Ave. becomes W. Huron St/I-94 Bus E. Turn right onto S. Main Street and take the 2nd left onto E. Liberty Street. 200 E. Liberty Street is on the right.
