

**ADMINISTRATIVE ORDER  
PERTAINING TO THE ASSIGNMENT OF CASES**

On May 23, 2019, the United States Court of Appeals for the Sixth Circuit appointed Joel D. Applebaum as a United States Bankruptcy Judge for the Eastern District of Michigan in the Flint location, effective May 31, 2019. To implement the assignment of cases to Judge Applebaum, this administrative order is entered pursuant to 28 U.S.C. § 154(b) and E.D. Mich. LBR 1073-1(c)(2). Accordingly,

**IT IS HEREBY ORDERED** that as soon as reasonably practicable, the Clerk shall reassign to Judge Applebaum all bankruptcy cases, and all adversary proceedings filed in such cases, that are currently pending in the Flint location, except for those cases and adversary proceedings that are listed on Exhibit A to this order, all of which shall remain assigned to Judge Daniel S. Opperman.

**IT IS FURTHER ORDERED** that as soon as reasonably practicable, the Clerk shall assign all bankruptcy cases and adversary proceedings that are hereafter filed in the Flint location to Judge Applebaum.
