HOW TO PAY A FEE ELECTRONICALLY

Payment of court fees (including filing fees and installment payments, copies, recordings of hearings, etc.) may be paid online via debit card, PayPal, or ACH (electronic payment from a bank account).

If you choose to pay from a checking or savings account (this process is referred to as “Automated Clearing House” or “ACH”), you will need to select an Account Type and enter the appropriate information for your account including:

- Financial institution routing number
 - Checking or savings account number and
 - Re-enter account number to confirm

- If you choose to pay via Debit Card, you will need to select the Debit option and enter the card payment information.

ONLINE PAYMENTS

**FOR COPIES: CONTACT THE CLERK'S OFFICE FOR TOTAL NUMBER OF PAGES AND ARRANGE FOR PICK UP OF DOCUMENTS AT A SPECIFIC COURT LOCATION.

ALTERNATIVELY, YOU MAY MAIL A SELF-ADDRESSED STAMPED ENVELOPE TO THE COURT AND HAVE YOUR COPIES MAILED TO YOU.

CM/ECF filers should continue to make payment of court filing fees directly in CM/ECF when filing a document with the court.

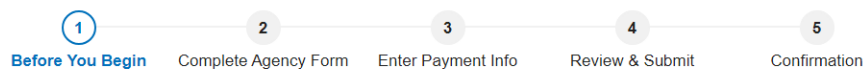


