ORDER PERTAINING TO THE ASSIGNMENT OF CASES


The United States Court of Appeals for the Sixth Circuit has appointed Bankruptcy Judge Mark A. Randon in this district. This administrative order sets forth the reassignment of the Court's cases and the procedure for assigning new cases. It is entered pursuant to 28 U.S.C. § 154(b) and Local Bankruptcy Rule 1073-1(c)(2). Accordingly,

IT IS ORDERED that:

1. **Pending Chapter 13 Cases.** On April 8, 2014, the Clerk shall reassign to Judge Mark A. Randon all of the pending Chapter 13 cases, and any adversary proceedings filed in such cases, that are presently assigned to Judge Steven W. Rhodes.
2. **Pending Chapter 7, 11, 12, and 15 Cases.** On April 8, 2014, the Clerk shall reassign to Judge Randon all of the pending Chapter 7, 11, 12, or 15 cases, and any adversary proceedings filed in such cases, that were reassigned from Judge Rhodes to the other bankruptcy judges of this district pursuant to Administrative Order No. 13-12 entered on August 14, 2013, except for such cases and adversary proceedings as are listed on exhibit A to this order, all of which shall remain with the bankruptcy judges presently assigned to such cases and adversary proceedings.

3. **Assignment of New Chapter 7, 11, 12, 13, or 15 Cases.** On April 8, 2014, the Clerk shall begin randomly assigning to Judge Randon all new Chapter 7, 11, 12, 13, and 15 cases on a proportionate basis in accordance with the Court's blind draw system.

IT IS SO ORDERED.
