## 73<sup>rd</sup> JUDICIAL CONFERENCE OF THE SIXTH CIRCUIT

On behalf of Chief Judge R. Guy Cole, Jr., and the Sixth Circuit Judicial Conference Planning Committee, I am pleased to invite you to register for the 73<sup>rd</sup> Judicial Conference of the Sixth Circuit to be held in Detroit, Michigan. We are excited about this year's program and are continuing efforts to streamline and facilitate Conference registration through our automated systems.

The Conference's headquarters will be the Detroit Marriott at the Renaissance Center with lodging accommodations at the same location. Thursday's program will open with a plenary session presented by Professor Bryan Stevenson, breakout sessions, a luncheon for conferees featuring Professor Noah Feldman, and another flight of breakout sessions. The day will conclude with a reception and banquet for conferees at Cobo Center, located about a quarter mile from the Renaissance Center. The evening will include a presentation of the American Inns of Court Award and remarks from Associate Justice Elena Kagan.

Friday morning's program features Dean Erwin Chemerinsky's review of the Supreme Court's term. The Conference will conclude by 11:30 A.M.
