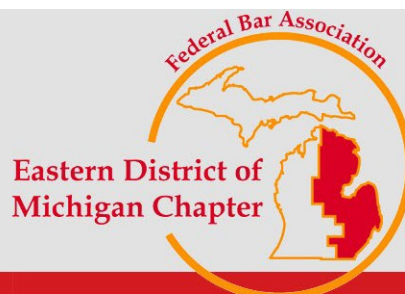
Last year, the late David Allard was honored as the second recipient of this prestigious award.

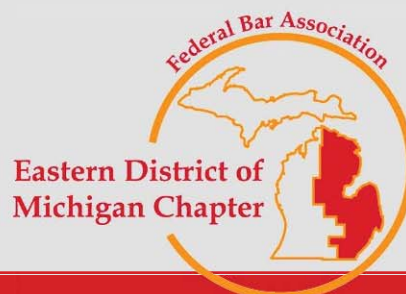
